### Registration:

Registration for all workshops, refreshers, and lower level 100/200 level classes will only be available by payment through the SBWFA website.

For all 300 and 400 level courses, federally employed students will need to register via IQCS or the Wildland Fire Learning Portal. All non-federally employed students must submit a hard copy nomination form to the course coordinator. Regional level 300 and 400 level courses require student prioritization and payment cannot be made until course selections are made.

# S-130/S-190/L180 : Firefighting Training; Intro to Wildland Fire Behavior; Human Factors on the Fireline

Prerequisites: None

Pre-work: Yes — I-100 available at: https://training.fema.gov/is/courseoverview.aspx?code=IS-100.b

This introductory course is designed to train entry-level firefighters referred to as a Firefighter Type 2 (FFT2). You will be introduced to and gain knowledge of the basic incident management organization, firefighting techniques, suppression equipment, safety, strategy/tactics along with fire behavior. Field exercises will be performed for valuable hands-on training. Includes L-180.

S-131: Firefighter Type 1

Prerequisites: Yes—Qualified as FFT2

Pre-work: None

S-131 is an eight-hour course designed to meet the training needs of the Firefighter Type 1 (FFT1). This course is designed to be interactive in nature. It contains several tactical decision games designed to facilitate learning the objectives and class discussion. Topics include fire line reference materials, communications, and tactical decision-making. This course is also designed to train Incident Commander Type 5 (ICT5) and Firefighter Type 1 (FFT1) to identify environmental factors and indicators of hazardous fire conditions, and how to use these indicators when implementing the Risk Management Process.

### S-211: Portable Pumps and Water Use

Prerequisites: None

Pre-work: None

This course is designed to provide knowledge and skills to design, set-up, operate, troubleshoot, and shut down portable water delivery systems. The focus is on portable pumps - it does not address water delivery for engines. Topics covered include: portable water delivery systems, equipment, roles and responsibilities, and system design and hydraulics. There is also a field exercise where students will apply what they learned in the classroom.

### S-212: Wildland Fire Chainsaws

Prerequisites: Yes—Qualified as FFT2

Pre-work: Yes — available at: https://www.nwcg.gov/publications/training-courses/s-212/pre-course-work

This is an instructor-led course intended to be presented at the local level. The course lessons provide introduction to the function, maintenance and use of internal combustion engine powered chain saws, and their tactical wildland fire application. Field exercises support entry level training for firefighters with little or no previous experience in operating a chain saw, providing hands -on cutting experience in surroundings similar to fireline situations.

### S-215: Fire Operations in the Wildland Urban Interface

Prerequisites: Yes-Qualified as FFT1

Pre-work: None

This is an instructor-led course intended to be presented at the local level. Instructional units include firefighter safety in the interface, managing human factors in the interface, pre-incident planning, sizeup and initial strategy, structure triage, structure protection overview, tactics in the interface, tactical operations and resource use in the interface, action assessment, plan update, and after action review.

S-219: Firing Operations

Prerequisites: Yes-Qualified as a FFT2

Pre-work: None

This course was developed using a blended approach to learning. Students are required to complete the online training portion of the course prior to taking the ILT. The course introduces the roles and responsibilities of a Firing Boss, Single Resource (FIRB), and outlines duties of other personnel who may engage firing operations. The course discusses and illustrates common firing devices and techniques. Although comprehensive in nature, the course work is not a substitute for the dynamic fire environment. The course provides students with important information regarding general tasks required to be successful. Any opportunity to show students a real ignition or demonstrate the use of an actual firing device will assist in transferring these new concepts and skills to the job. There is an optional field day outlined in the course, it is the discretion of the delivery unit to include the field day; however, if logistically feasible it is suggested by NWCG that a field day be conducted.

S-230: Crew Boss

Prerequisites: Qualified as a FFT1, S-290

Pre-work: Yes — available at: https://www.nwcg.gov/publications/training-courses/s-230/course-materials

This is a classroom course designed to produce student proficiency in the performance of duties associated with the Single Resource Boss position from initial dispatch through demobilization to the home unit. Topics include operational leadership, preparation and mobilization, assignment preparation, risk management, entrapment avoidance, safety and tactics, offline duties, demobilization, and post incident responsibilities.

S-231: Engine Boss

Prerequisites: Qualified as a FFT1, S-230

Pre-work: None

This is a skill course designed to produce student proficiency in the performance of the duties associated with Engine Boss, Single Resource (ENGB). Topics include engine and crew capabilities and limitations, information sources, fire size up considerations, tactics, and wildland urban interface.

S-236: Heavy Equipment Boss

Prerequisites: Yes—Qualified as a FFT1

Pre-work: Yes— available at: https://www.nwcg.gov/publications/training-courses/s-236/pre-course-work

This is a skill course designed to meet the training needs of a Heavy Equipment Boss, Single Resource (HEQB) on an incident as outlined in the NIMS: Wildland Fire Qualification System Guide, PMS 310-1, and the position taskbook developed for the position. Primary considerations are tactical use and safety precautions required to establish and maintain an effective dozer operation. A field exercise is required as part of the course.

S-270 : Basic Air Operations

Prerequisites: None

Pre-work: Yes— available at: https://www.nwcg.gov/publications/training-courses/s-270/pre-course-work

This course covers aircraft types and capabilities, aviation management and safety for flying in and working with agency aircraft, tactical and logistical uses of aircraft, and requirements for helicopter take-off and landing areas. *Note:* The regulations, procedures, and policies addressed in this course are primarily those governing federal agency and ICS operations. State, county, or other political subdivisions using this course will need to consult their agency having jurisdiction with respect to regulations, procedures and policies. S-330: Task Force / Strike Team Leader

Prerequisites: Qualified as any Single Resource Boss

Pre-work: Yes— available at: https://www.nwcg.gov/publications/training-courses/s-330/course-materials

This course is designed to meet the training requirements outlined in <u>NIMS: Wildland Fire Qualification System Guide</u>, <u>PMS 310-1</u> and the position task books developed for the positions of Task Force Leader and Strike Team Leader. Most examples and exercises in this package are specific to wildland fire suppression, although some all-hazards exercises are included. <u>Nominations</u> for this course must be completed through IQCS (IQCS# 407) with the deadline being November 10, 2023. Selections will be made utilizing the SWA prioritization process. Students can register once acceptance letters have been received.

S-339: Division / Group Supervisor

Prerequisites: Qualified as TFLD, or Qualified ICT3

Or can be Qualified ICT4 with either STCR or STEN Qualification

Pre-work: Yes—available at: https://www.nwcg.gov/publications/training-courses/s-339/course-materials

This course prepares students to perform in the role of Division/Group Supervisor (<u>DIVS</u>). It provides instruction in support of the specific tasks of the Division/Group Supervisor, but will not instruct students in general management/supervision or in the Incident Command System (<u>ICS</u>), both of which the student should learn through prerequisite work. Topics include division or group management, organizational interaction, division operations, all-hazard operations, and tactical decision games (optional). The pre-course work consists of a professional reading assignment that can take from four to eight hours to complete. There is a final examination in this course. <u>Nominations for this course must be completed through IQCS</u> (<u>IQCS# 233</u>) with the deadline being <u>November 10</u>, 2023. <u>Selections will be made utilizing the SWA prioritization process</u>. <u>Students can register once acceptance letters have been received</u>.

S-359: Medical Unit Leader

Prerequisites: Current certification as EMT or Equivalent

Pre-work: None

This course is designed to provide the skills and knowledge needed to perform in the role of Medical Unit Leader (MEDL). Topics include gathering information, organizing the medical unit, supervising the unit, evaluation, documentation, and demobilization.

### FI-110: Wildland Fire Observations and Origin Scene Protection for First Responders

Prerequisites: None Pre-work: No

The primary emphasis of this course is to teach sound wildland fire observations and origin scene protection practices that enable first responders to a wildland fire scene to perform proper origin scene protection procedures. The course is presented by short lectures, electronic presentations, exercises, and class discussion.

### FI-210: Wildland Fire Origin and Cause Determination

Prerequisites: Recommended students have law enforcement or firefighter experience.

Pre-work: Yes — available at: https://www.nwcg.gov/publications/training-courses/fi-210/pre-course-work

The primary purpose of this course is to provide a consistent knowledge and skill base for the Wildland Fire Investigator (INVF). The concepts taught in this course will help an INVF perform at an acceptable level on a national basis without regard to geographic boundaries. The course is presented by lectures, electronic presentations, field exercises, and class discussion. Although formal night sessions are not required, past FI-210 investigation teams have recognized the need to work together after hours to complete their investigation presentation. You are encouraged to keep your evenings open for these team sessions. Selections for this course will be made by December 18, 2023. Payments will be refunded to students that are not selected.

### L-280: Followship to Leadership

Prerequisites: Completion of L-180

Pre-work: Yes — available at: https://www.nwcg.gov/publications/training-courses/I-280/course-materials

This training course is designed as a self-assessment opportunity for individuals preparing to step into a leadership role. The course combines one day of classroom instruction followed by a second day in the field with students working through a series of problem solving events in small teams (Field Leadership Assessment Course). Topics include leadership values and principles, transition challenges for new leaders, situational leadership, team cohesion factors, ethical decision making, and after action review techniques. Some course delivery may be arduous in nature.

### L-381: Incident Leadership

Prerequisites: Completion of L-180, Qualified as any Strike Team Leader, TFLD, ICT4, any support leader or Supervisory Dispatcher

Pre-work: Yes-available at:

L-381 is targeted at leaders of divisions, groups, or Type 3 incidents. The intent of the course is to provide these individuals with the leadership tools to effectively exert command and control over a quickly-assembled team in a time-constrained and rapidly-changing incident environment. Beyond a set of tools and techniques, this training experience should be designed to make an emotional and lasting impact. Essential guiding principles for achieving this impact include: enhancing the students' understanding of the human dimension when leading others in dynamic work environments; utilizing experiential training techniques that will engage students in ways that challenge them to perform under realistic and high-stress situations; and motivating students to examine their role, strengths, and weaknesses in that role. Nominations for this course must be completed through IQCS (IQCS#362) with the deadline being November 10, 2023. Selections will be made utilizing the SWA prioritization process. Students can register once acceptance letters have been received.

M-410: Facilitative Instructor

Prerequisites: None

Pre-work: Yes—available at: https://www.nwcg.gov/publications/training-courses/m-410/course-materials

This training course is designed to help students become effective facilitative instructors. The purpose of this course is to improve training delivery and quality by presenting instructional methods with an emphasis on student-oriented adult training techniques. This course is designed for students to meet NWCG instructor requirements. Nominations for this course must be completed through IQCS (IQCS# 586) with the deadline being November 10, 2023. Selections will be made utilizing the SWA prioritization process. Students can register once acceptance letters have been received.

RT-130 : Annual Fireline Safety Refresher Training

Prerequisites: Qualified as FFT2

Pre-work: None

Annual Fireline Safety Refresher Training should be designed to provide up to date fireline safety information to employees holding Incident Command System qualifications requiring this training per the 2006, PMS 310-1, Wildland Fire Qualification System Guide. Individual sessions of Annual Fireline Safety Refresher Training should contain content pertinent to the registered students.

ICS-300: Intermediate ICS

Prerequisites: Completion of Basic ICS Course (I-200)

Pre-work: None

This course provides description and detail of the Incident Command System (ICS) organization and operations in supervisory roles on expanding or Type 3 incidents. Topics include ICS fundamentals review, incident/event assessment and agency guidance in establishing incident objectives, Unified Command, incident resource management, planning process, demobilization, transfer of command, and close out. This course was developed in conjunction with the U.S. Fire Administration (H465) and the Emergency Management Institute (G300). These courses are built on the same lesson objectives and content as the NWCG I-300 course and are interchangeable; they are all National Incident Management System (NIMS) compliant.

ICS-400: Advanced ICS

Prerequisites: Completion of Intermediate ICS (I-300)

Pre-work: None

This course directs the student towards an operational understanding of large single-agency and complex multi-agency/multi-jurisdictional incident responses. Topics include fundamentals review for command and general staff, major and/or complex incident/event management, area command, and multi-agency coordination. This course was developed in conjunction with the U.S. Fire Administration (H467) and the Emergency Management Institute (G400). These courses are built on the same lesson objectives and content as the NWCG I-400 course and are interchangeable; they are all National Incident Management System (NIMS) compliant.
